The purpose of the IAF MLA is to provide users in countries with ABs that are IAF MLA signatories with the assurance that certification bodies (CBs) and validation/verification bodies (V/VBs) in other economies operate to the same standards as those in their own economies for certificates and statements in the fields of:









Accreditations granted by IAF MLA AB signatories are recognised worldwide therefore reducing costs and adding value to industry and consumers.

The MLA contributes to the facilitation of world trade by eliminating technical barriers to trade. IAF works to find the most effective way of achieving a single system to meet the objective of "Accredited once, accepted everywhere".

The IAF MLA Mark can be used by ABs to demonstrate their status as a signatory to the IAF MLA. If approved by the AB, accredited conformity assessment bodies (CABs) can also use the IAF MLA Mark in combination with the accreditation symbol on their certificates or statements, provided that these are issued under a granted IAF MLA scope.

The IAF MLA Mark demonstrates that the certificate or statement has been issued by a CAB that is accredited by an IAF MLA signatory and is thus traceable to the highest authority. It is an assurance that the certificate and the issuing body are of a high standard of competence and may be trusted, as they are recognised as complying with the same set of standards at the global level.

The IAF MLA is composed of IAF MLA main scopes and corresponding IAF MLA sub-scopes.

Certificates issued on the basis of an IAF MLA main scope are considered "equally reliable" because the CABs conform to the same standards.

Certificates issued on the basis of an IAF MLA sub-scope are considered "equivalent" as they are based on the same IAF endorsed standards or sector schemes. Sub-scopes are divided into two categories (Level 4 and Level 5). Level 4 sub-scopes are IAF endorsed normative documents used by ABs in conjunction with main scope documents to assess a CB's competence in a specific sector. Level 5 sub-scopes are IAF endorsed normative documents used by CBs.

- Level 1 is the endorsed normative document for Accreditation Bodies
- Levels 2 and 3 are the main scopes consisting of accreditation programs and endorsed normative documents
- Levels 4 and 5 are the sub-scopes consisting of applicable documents and endorsed normative documents

As a supplement, IAF has developed a fast-track sub-scope evaluation process based on the evaluation of the Global Food Safety Initiative (GFSI) benchmarking of food sector schemes. A corresponding Memorandum of Understanding between IAF and GFSI is in place to facilitate the acceptance of GFSI benchmarked schemes as IAF MLA sub-scopes.

Signatories to the IAF MLA

The IAF MLA has been structured to build on existing and developing regional MLA/MRAs established around the world. Therefore, IAF has formally recognised the MLA/MRA programs of five Regional Accreditation Groups (RAGs):

ABs recognised under these Regional MLA/MRAs may apply to the IAF for recognition under the IAF MLA on the basis of the acceptance of the mutual recognition arrangements established within these organisations.

Membership in the IAF MLA is facilitated by membership in the recognised RAGs' (AFRAC, APAC, ARAC, EA or IAAC) MLA/MRAs for recognised scopes and sub-scopes. IAF members who are also signatories of these regional MLA/MRAs can be accepted into the IAF MLA for recognised scopes and sub-scopes.

Originally, unaffiliated ABs applied directly to IAF to become an IAF MLA signatory.

Since the end of 2018, there are no unaffiliated IAF Member ABs as all IAF AB members are now also members of a RAG.

Another RAG has been working on establishing its MLA/MRA. In recognition of this, the South African Development Community Cooperation in Accreditation (SADCA) has been included in the statistics that follow.

The number of signatories to the IAF MLA has grown in recent years, providing confidence to businesses and regulators in an increasing number of economies. A full list of IAF MLA signatories is available here and new IAF MLA signatories and scope extensions, as noted during the 2021 IAF General Assembly, are referenced in Annex 1 of this report. The graphs below show the evolution of the number of signatories at the regional level for different MLA scopes.




Number of signatories for Certification of Products, Processes and Services




Number of signatories for GHG Validation/ Verification













A total of 11,621 CBs and V/VBs are currently accredited, an increase of 12% since 2020.

These numbers reflect the total number of scopes covered by accredited CABs in the RAGs, including where a CAB is accredited for more than one sub-scope.

Peer Evaluation Process

ABs are admitted to the IAF MLA only after a stringent evaluation of their operations by a peer evaluation team which is charged with ensuring that applicants comply fully with both international standards and IAF requirements. IAF, the RAGs and their AB members, invest significant resources to ensure and maintain the

integrity of the MLA through robust peer evaluations. Each regional MLA/MRA undergoes regular review. The peer evaluation process is ongoing and extensive, covering all RAGs and their signatories in a regular evaluation programme.

IAF and ILAC jointly undertake evaluations of each RAG through teams of resources provided by other Regions. In 2021, the following regional evaluations were conducted:



Witnessing Testing (ISO/IEC 17025), Greenhouse Gases (ISO 14065), Inspection, Product



Witnessing Calibration, Management System, Product, Medical testing



Initial evaluation; witnessing Management System, Calibration, Testing (ISO/IEC 17025)



Re-evaluation for joint extension for Reference Material Producers (RMP) and Proficiency Testing Providers (PTP); witnessing Testing (ISO/IEC 17025), Inspection, Management System (witnessing EnMS), Product, RMP and PTP, Person

Expanding the Scope of the IAF MLA

The IAF MLA is reviewed on an on-going basis to better serve the needs of stakeholders. A number of evaluations of private sector schemes to become IAF MLA sub-scopes were in progress in 2021, and Foundation FSSC's FSSC 22000 certification scheme was endorsed on 12 March 2021.

FSSC 22000 outlines requirements for the audit and certification of food safety management systems (FSMS) or FSMS and quality management systems (QMS) for organizations in the food supply chain. Based on ISO/IEC 17021-1 and ISO/TS 22003, it provides the standard and framework for independent, recognized third party management system certification of animal farming, food, feed, biochemicals and packaging (materials) manufacturing, transport and storage, catering and retail/wholesale organizations. FSSC 22000 has been benchmarked and recognized by the Global Food Safety Initiative since 2010.





In May 2021, EA applied to IAF to be recognised for the IAF MLA sub-scope FSSC 22000. 19 ABs were eligible for recognition after IAF accepted EA's recognition in July 2021. The next re-evaluation of EA by IAF/ILAC is scheduled to begin no later than July 2022.



APAC added the following scopes and sub-scopes to the APAC MRA in 2021: Biobanking, Anti-Bribery Management Systems (ABMS), Business Continuity Management Systems (BCMS), Food Safety System Certification (FSSC 22000), Validation and Verification, and Validation and Verification of Environmental Information.



IAAC is working to expand its MLA to FSSC 22000.



ARAC currently operates in the following MLA scopes: Quality Management Systems (QMS), Environmental Management Systems (EMS), Food Safety Management Systems (FSMS), and Product and Personnel Certification.



- In 2021, AFRAC underwent a re-evaluation by IAF, which included an extension of scope evaluation for the scopes of Product Certification and Persons Certification.
- In 2021, AFRAC received proposals to extend its MRA to include the Management System sub-scopes of:
 - ISO 21001:2018 Educational organizations
 Management systems for educational organizations
 - » ISO 13485: 2016 Medical devices Quality management systems
 - » ISO/TS 22003:2013 Food safety management systems
 - » ISO 28001:2007 Requirements for bodies providing audit and certification of supply chain security management systems
- AFRAC has applied to IAF to increase its scope to include Product Certification and Certification of Persons.



SADCA has not yet undergone any activities to extend its scope at this stage.

MLA Monitoring and Improvement **Activities**

IAF is committed to monitoring and reviewing the MLA to ensure that it continues to meet the needs of stakeholders. In addition to consulting widely with stakeholders, IAF carries out a number of programmes and activities to continuously improve the value and effectiveness of the MLA.



Complaints provide a valuable mechanism for receiving feedback relating to the effectiveness of the MLA. This often confirms that the MLA is working effectively and that the process in place is suitably robust. It can also provide information that can be used to improve areas of the MLA.

The following numbers of complaints were raised during this period:

COVID-19 Response

Following the declaration of COVID-19 as a pandemic and the imposition of social distancing and travel restrictions, IAF immediately began developing resources in response, working closely with stakeholders to address their needs. In collaboration with ILAC and the RAGs, a framework of measures was developed to allow assessments and peer evaluations to be performed remotely, guaranteeing the maintenance of a high level of competence and harmonization.

In 2021, IAF and ILAC published several new documents relating to the pandemic:



- IAF/ILAC Approach to Remote Peer-Evaluations of Regions and Single Accreditation Bodies During the COVID-19 Pandemic, an addendum to IAF/ILAC A1 IAF/ILAC Multi-Lateral Mutual Recognition Arrangements (Arrangements): Requirements and Procedures for Evaluation of a Regional Group and IAF/ILAC A2 IAF/ILAC Multi-Lateral Mutual Recognition Arrangements (Arrangements): Requirements and Procedures for Evaluation of a Single Accreditation Body. This addendum provides policies for the role and conduct of remote peer evaluations and allows for a more flexible approach to remote witnessing activities.
- The joint statement *Replacement of Assessments During the COVID-19 Pandemic*, which addresses situations where pandemic-related circumstances such as travel restrictions, social distancing, and health and safety considerations disrupt mandatory scheduled on-site or remote assessments by IAF MLA or ILAC MRA signatories. This statement allows for an off-site review of documentation to replace an assessment in extraordinary circumstances caused by the pandemic and only under specific conditions as defined in the statement.

These documents supplement resources published in 2020, which include:

- An IAF Statement on COVID-19, which highlights relevant IAF documents on extraordinary events and the use of information and communications technology in audits and assessments.
- A series of COVID-19 FAQs endorsed at the 2020 IAF General Assembly, which helps certificationbased stakeholders (certified clients, certification bodies, accreditation bodies, scheme owners and regulators) maintain a harmonized approach.
- An IAF-ILAC Statement re Delayed Evaluations -March 2020, which provides guidelines that ensured the consistent transition of all IAF MLA and ILAC MRA signatories to the latest version of ISO/IEC 17011.

The COVID-19 hub on the IAF website contains links to all current resources.

The IAF MLA Management Committee and ILAC Arrangement Management Committee continued meeting remotely following the imposition of travel restrictions. Additionally, IAF collaborated with other international organizations to share experiences of working remotely and highlight the role of conformity assessment in supporting health and safety during the pandemic.

IAF, ILAC and ISO undertook a joint survey in 2021 to obtain the views of a diverse range of stakeholders on the use of remote techniques in audits, assessments and evaluations, which has increased during the pandemic. In total, 4350 responses were received. Results showed that a large majority of respondents prefer remote or blended audits, assessments, and evaluations, feel that remote activities provide as much confidence as on-site, and would like to see continued or increased use of remote activities in the future. Improvement Activities

IAF consults widely with stakeholders to deliver a high standard of conformity assessment, and to provide stakeholders with a value-added outcome. The following activities were carried out to improve the MLA in 2021:



Collaboration with ILAC has continually improved to a point where only IAF/ILAC Joint Management Committee (JMC) meetings are held and there are no separate meetings of the IAF MLA MC and the ILAC AMC. This provides for a better understanding of the few different requirements and the many commonalities in the MLA area between the two organisations. Changes to the IAF membership on the JMC was implemented on 01 January 2021 to achieve a more balanced representation from both organisations.

- The EA peer evaluation process is under continuous review. Regulation (EC) No 765/2008 reinforces the role of EA and its peer evaluation role in both voluntary and regulated sectors. EA aims to support and harmonize the implementation of stringent rules to achieve consistency throughout Europe, as well as greater transparency and acceptability to all, including national authorities. The peer evaluation process is also further strengthened to accommodate the specific needs of regulatory fields to raise the assurance of regulators and stakeholders that ABs' technical competence is thoroughly assessed.
- The Multilateral Agreement Council (MAC) project aiming at re-engineering the peer evaluation system, one of the key actions of the EA Strategy 2025, progressed in 2021 and is nearing its goal.
- The MAC has been finalising the revision of EA-2/02: EA Procedure for the Evaluation of a National Accreditation Body, as well as the revision of the MAC Terms of Reference in order to include the role and responsibilities of the Secretariat and to annex the competence criteria for decision-makers.
- The MAC has also been developing five supplements to EA-2/02 in order to set out:
 - » EA-2/02 S1: Description of Competence Criteria of the EA Secretariat Personnel Involved in the Management of the Peer-Evaluation Process
 - » EA-2/02 S2: Circumstances and Process of Involving EA Technical Committees in Peer-Evaluation Issues
 - » EA-2/02 S3: Risk-Based Approach for the Planning of a Peer Evaluation of a National Accreditation Body
 - » EA-2/02 S4: Procedure for Remote Peer Evaluations during the COVID-19 Pandemic

- » EA-2/02 S5: Procedure for Remote Decision-Making
- EA-2/02 S1, S2 and S4 were published in February 2022; the S3 and S5 supplements, whose title may still be changed, should be available in the first half of 2022.

APAC

Review of the APAC MRA evaluation procedures (APAC MRA-001) is underway to take into account experiences over the past three years and remote evaluation. APAC also revised and republished APAC TEC1-008 *Guidance for Accreditation of Reference Material Producers* and APAC TEC1-001 *APAC Guidance on Scopes of Accreditation for Biobanks*.



In 2021, IAAC created a new Technical Secretariat position to help improve the MLA processes and to develop new MLA scopes.



- In its second edition and on the occasion of World Accreditation Day (WAD) 2021, ARAC organized the
 Arab Accreditation Week (AAW) during the period 06-11 June 2021 under the theme "Together towards
 enhancing the role of accreditation in supporting the achievement of the Sustainable Development Goals
 (SDGs) in the Arab region".
- Several online activities held during the AAW demonstrated ways to further develop the accreditation
 infrastructure in the Arab region and highlight the pivotal role it plays in achieving the Sustainable
 Development Goals (SDGs), in addition to capacity building activities implemented to strengthen the
 ARAC member competencies:
 - Webinar on the benefits of ARAC MLA recognition to the ARAC AB members and the benefits of accreditation to governments: The event, organised as part of the ARAC communication strategy, further contributed to strengthening the visibility of ARAC inside and outside the accreditation community, supporting recognition and acceptance of the IAF MLA and ARAC MLA and services/products provided under accreditation issued by the ARAC AB members. By the end of the awareness sessions, the participants had a good understanding of how accreditation, the ARAC MLA and its members benefit regulators, industries, economies and CABs.
 - Webinar on accreditation in the digital era: This webinar aimed to review the experiences from ARAC ABs on how they had operated under the specific situation of COVID-19 by using information and communication technologies while, most importantly, maintaining the integrity of a robust accreditation system. The event gave ARAC AB members a common understanding and a guidance on how to go digital in a harmonized way with adequate digitalization tools to operate efficiently and effectively.




AFRAC continues to promote the IAF MLA and ILAC MRA in the current Continental Free Trade Area
(FTA) discussions. The MRA has already been incorporated in the FTA between SADCA, the East African
Community and the Common Market for Eastern and Southern Africa, which consists of 26 economies in
Africa.

- The AFRAC MRA brochure is aligned to ILAC MRA and IAF MLA requirements.
- AFRAC publishes a newsletter twice yearly with articles promoting the AFRAC MRA and IAF MLA as well
 as WAD celebrations where IAF and ILAC are given prominence by ABs and National Accreditation Focal
 Points (NAFPs) across the continent.
- AFRAC documents are aligned to the IAF requirements, with continued adoption and promotion of IAF mandatory and guidance documents by AFRAC.
- AB transitions to new standards are continuously monitored by AFRAC.
- The incorporation of AFRAC as a legal entity is in its final stages.



- AB transitions to new standards are continuously monitored by SADCA.
- SADCA documents are aligned to the IAF requirements, with continued adoption of IAF mandatory and guidance documents by SADCA.
- SADCA publishes an annual newsletter promoting SADCA AB and NAFP members, WAD and the IAF MLA.
- SADCA posts articles on the website under latest news and in the SADCA summit brochure.

- In order to support the ongoing improvement of EA's pool of evaluators, three refresher training sessions were organised remotely in 2021 due to the health and travel conditions related to the COVID-19 pandemic:
 - » The first refresher training session held on 8-9 June 2021 was dedicated to Management Systems Certification and Certification of Persons. 31 participants from 20 NABs took part in the program covering:
 - ♦ The procedural aspects related to the peer-evaluation process.
 - ♦ The more technical aspects directly related to the specific fields and applicable standards, namely ISO/IEC 17021-1 and 17024.
 - The second refresher training session held on 15-16 June 2021 gathered 26 team leaders and deputy team leaders from 16 NABs to discuss:

 - ♦ The application review and preparation of the evaluation.
 - » The third refresher training session held on 8-9 December 2021 was dedicated to testing, medical examination and reference material producers. 33 peer evaluators from 22 NABs participated in the program covering:
 - The procedural aspects related to the peer evaluation process.
 - The more technical aspects directly related to the specific fields and applicable standards, namely ISO/IEC 17025, ISO 15189 and ISO 17034.

- · Other training sessions:
 - » Jointly with the European Network of Forensic Science Institutes (ENFSI), EA organised an online seminar on accreditation in the sector of crime scene investigation (CSI) on 22 March 2021. Initiated by the EA Inspection Committee (IC), this seminar enabled six speakers from ENFSI to share their experience in accreditation of forensic laboratories in Europe with almost 300 participants. As part of the AFORE (Accreditation of Forensic Laboratories in Europe) project, aiming to support forensic science laboratories across the European Union Member States to move towards accreditation, the objective of this seminar was to promote awareness of CSI processes towards EA and provide a better understanding of the whole forensic process, including:
 - ♦ CSI and laboratory activities (e.g., logistics, search for traces, different types of traces).
 - The different roles of personnel conducting CSI (e.g., crime scene manager, scene of crime examiner, forensic scientist).
 - The principles and importance of CSI (such as documentation of the scene, identification of the crime, etc.).
 - A concrete rape and murder case.
 - The benefits of accreditation of CSI.
 - » Another seminar was organised together with the European Union Agency for Cybersecurity (ENISA) on 24 September 2021 to support EA NABs in the implementation of the European candidate cybersecurity certification (EUCC) scheme and to start with the accreditation of CBs and IT Security evaluation facilities (ITSEFs) as soon as the scheme is published in the Official Journal of the European Union in 2022. More than 100 participants including representatives from EA NABs and Recognised Stakeholders, as well as National Cybersecurity Certification Authorities (NCCA), attended this EA/ENISA webinar focused on the following issues under the Cybersecurity Act (CSA):
 - ♦ Common Criteria based EUCC.

 - » EA launched its eLearning platform in summer 2021. So far one e-Learning module dedicated to Regulation (EU) 2015/757 on the Monitoring, Reporting and Verification (MRV) of Carbon Dioxide Emissions from Maritime Transport has been made accessible.

IAF Resolution 2021-22 – IAF Validation and Verification MLA Structure

The General Assembly noted that, on the recommendation of the IAF Executive Committee, IAF Members had endorsed by letter-ballot the transition to a single IAF Validation and Verification MLA under ISO/IEC 17029:2019 under the following conditions:

- Assessor Competence requirements for the transition to ISO/IEC 17029:2019:
 Competent for ISO 14065:2013, IAF MD 14, IAF MD 6 + training on ISO/IEC 17029:2019 by competent persons
- An on-site or remote assessment against the full ISO/IEC 17029:2019 be done on Validation and Verification Bodies before granting accreditation against ISO/IEC 17029:2019
- For ABs currently an MLA signatory to the main scope ISO 14065:2013: After
 the AB successfully transitions its IAF MLA signatory status to include ISO/IEC
 17029:2019, the AB will be a signatory to both the main scope ISO/IEC 17029 and
 the level 4 sub-scope ISO 14065
- The IAF MLA for the main scope ISO 14065:2013 will cease existing at the end of the transition deadline to ISO 14065:2020 as stipulated in IAF Resolution 2019-19.

Required actions from Regional Accreditation Groups that are signatories to the IAF Validation and Verification MLA under ISO 14065:2013 have to be followed as included in the report of the IAF MLAC of 29 April 2021.
